The top-of-the-range 2014 Poesía is a blend of 60% ungrafted Malbec with 40% Cabernet Sauvignon from 13 hectares of vines planted 83 years ago at some 900 meters in altitude in Luján de Cuyo. It fermented in French oak and stainless steel vats with indigenous yeasts and long macerations. It matured in new French oak barriques for 28 months before being bottled. This is a selection of different lots that were aged separately in barrels, with the best barrels selected to create this top cuvée. There was only one year when they co-fermented the two varieties, but in general they keep them separate. In reality, they prefer to separate the varieties so that later they can make selections. This is super elegant, sleek and polished, quite different from the idea most people tend to have about a red from Luján. The two varieties are very integrated, and the wine feels superbly balanced. The tannins are super elegant, harmonious and nuanced, clean, focused and long. This should age very nicely in bottle. 11,000 bottles produced.

The 2013 Poesía is a blend of Malbec with 40% Cabernet Sauvignon, the percentage of varieties found in the vineyard, from 13 hectares of ungrafted vines planted 85 years ago at some 900 meters altitude. It fermented in a combination of oak and stainless steel tanks with indigenous yeasts and extended maceration. It matured in new French oak barriques for two years before being bottled. I think this is the most beautiful wine I've tasted from Poesía, still a very young and undeveloped wine with subtle aromas of violets and fine spices, still young and lively, but subtle and elegant, nuanced and insinuating. It developed some more balsamic nuances, with hints of camphor. But, it's the palate where the wine shows its true colors, classically proportioned, elegant, balanced, with symmetry and a fine texture. The two varieties are nicely integrated; they believe in blends, which for them is the best way to achieve complexity. I'd love to see this wine in ten years, as I believe it will age beautifully. It can be drunk now, but it should improve in bottle.

The 2012 Poesía, which follows more or less the same formula vintage after vintage, is a 60/40 blend of old-vine ungrafted Malbec and Cabernet Sauvignon which matured in new French oak barrels for two years after fermenting in a combination of stainless-steel and oak vats with indigenous yeasts. The really showy nose is redolent of violets and red cherries, really expressive, with a smoky hint, also a little meaty. The palate is medium-bodied with a soft texture and polished tannins with some earthiness (is it the Cabernet?) and moderate acidity. They do not acidify and the wines show the vintages and the place. This is a very nice blend. I had a preview of the 2013 and 2014 vintages, still unbottled, and I really liked 2013 too. 2014 it's still very young, but very balanced. Even though this 2012 is approachable now, I'd give it one more year in bottle, and it should also be able to age for quite long. I compare this 2012 to 2010, 2008 and 2004, vintages that are evolving nicely. It's quite remarkable that the wine has aged in new barrels and the oak is not noticeable at all. Also the two varietals are very integrated. It's always interesting to taste two vintages of the top wine from a winery side by side.

The 2008 still boasts a deep, bright ruby-red color and its pure, vibrant aromas of black cherry, black raspberry, cocoa powder, graphite and woodsmoke are enlivened by a subtle floral note. It's not the most opulent release of Poesia to date, as 2008 was generally a vintage of moderate ripeness for red grapes in Mendoza, but it may be the most suave and best balanced. On the palate, dark fruit flavors are accented by minerals, licorice, fresh herbs and flowers, while the finish features a fine dusting of tannins and echoing juicy length. I was reminded of both Right Bank Bordeaux and youngish Bandol, but with much more pliant tannins than those often fierce Mourvèdre wines.

A glass-coating opaque purple color, it reveals an outstanding bouquet of toasty new oak, exotic spices, incense, espresso, dark chocolate, and assorted black fruits. On the palate it displays an elegant personality in a slightly restrained style. The balance and flavors are first class and there is enough structure for 4-6 years of cellaring. Its drinking window extends from 2014 to 2028.

Went to a vertical tasting of Poesia, the Argentine blend of mostly Malbec with some Cabernet Sauvignon from Patrice and Hélène Garcin, the prominent Bordelais château owners-Barde Haut, Clos L'Eglise, Haut Bergey, and Branon... the first vintage was 2002. They were all impressive, but the current release, the 2008, is very stunning. The wine is not cheap \$60-70, but something from Napa or Bordeaux this fine would be in excess of \$100. The telltale floral notes, lots of licorice, espresso and blackberry and blueberry fruit... certainly full-bodied with very sweet well-integrated tannin... what like is the window for drinking this is very broad... already complex and delicious, this wine should last 10-20+ years... Big Jay scored it in the low 90s... I am much higher on it than that... but than again I am very bullish on these old vine, low yielding Malbec vines from top terroirs in Argentina... give it a try and let me know what you think!

"It is difficult to exaggerate how much Argentine wines have changed in the past few years. Until recently a typical Argentine wine was a full-throttle red of almost monstrous proportions, but a recent tasting of almost 100 of the country's finer wines suggested that many of the most ambitious winemakers are consciously seeking more finesse in their wines. The key to this has been a noticeable trend to planting vines ever higher up in the Andean foothills, and further and further south, away from the equator. In the south of the country, Argentine Patagonia with its subregion, Rio Negro, is now a serious wine producer in its own right. And a significant proportion of Argentine vineyards are now at more than 1.000m above sea level (in Europe's much feebler sunshine, 500m is popularly regarded as an effective upper limit for successful grape ripening). For what it's worth, I gave that particularly emblematic wine 17 points out of 20 but I ended up giving 17.5 out of 20 to all 16 wines, and a score of 18 out of 20 - which for me is a very high score indeed - to seven wines, those in the box below. A significant proportion of the fruit that went into these wines was grown on vines that are at least 50 years old, and therefore capable of producing extremely concentrated, interesting juice. But as the vines in the newer, cooler wine regions mature, they are expected to produce even finer wine than the old timers in the traditional warmer regions' lower altitudes. With the sole exception of Nicolas Catena Zapata, which is based on Cabernet Sauvignon, all of my 18 pointers happen to be Malbecs, but of course Argentina is not just Malbec. Indeed it is not just red wine. It has its own headily perfumed white wine grape Torrontes, a descendant of Muscat, which in its finest incarnations such as Colome Torrontes 2007 Salta, would make a great-value substitute for a smart Condrieu from the northern Rhône Valley. Then there is Argentine Chardonnay, which can be uncannily fine. California winemaker Paul Hobbs, whose own American Chardonnays fetch impressive prices, is an old Argentina hand, and argues that although the precise origins of Argentina's Chardonnay cuttings remain obscure, it is the stoniness of the soils in its most successful sites that imbue it with real class. His ex-employer Nicolas Catena maintains that altitude is the key to Chardonnay quality in Argentina. There is still much to be discovered in South America's dominant wine-producing country - which is presumably part of its charm for all those French, Spanish, Italian and Austrian wine producers who have moved there. Head of the generic body, Susana Balbo of Dominio del Plata winery, worries about those winery owners who leave the business altogether after less than five years. "Part of the reason is that their business plan was flawed in the first place, but also we find that they were making the wrong style of wine," she says. Too much extraction, wines that are too rustic. Argentina's growth is in mid-priced wines with real balance."

"A recent tasting in London of self-professed Argentine 'super reserves' was quite patchy and revealed one of the downsides of a generic representative body such as Wines of Argentina (WoA). The UK arm of the WoA does a great job in promoting Argentine wines but cannot, for political reasons, decide which wines genuinely deserve to be described as 'super reserves'. When I asked how the wines had been selected, I was told that an invitation was sent out to all the members to submit their top icon wine but that it 'got a little lost in translation'. Nevertheless I was delighted to have the chance to taste wines of new WoA members such as Achaval-Ferrer, one of my current favourite producers in Mendoza. The 1977 Weinert Star Malbec was very interesting and seemed to divide tasters between admiration and nose-wrinkling. The tasting was held at the new branch of the Gaucho restaurant group inside the O2 (once 'Millennium') dome by the Thames in east London - a great location but one occasionally prone to wafting aromas of top-notch grilled steak, even if some of the wines did smell independently meaty. The wines are grouped as follows: first pure Malbecs, then Malbec-dominant blends, then other blends, then other varietals. The Chacra Pinot Noirs were excellent - it's just a shame they are pretty expensive. All the wines had been decanted an hour or so before the tasting - with the added benefit that we didn't have to expend too much energy picking up the bottles. Approximate UK retail prices are given where known. Most if not all of these wines are available in the US (www.wine-searcher.com should help), where consumers seem to have been more willing to pay the higher prices that some of these wines deserve. The information in italics about vineyard location and winemaking was supplied by the producers. My drinking dates are generally quite conservative. Although some wines will age for longer, I think most will benefit from earlier drinking to enjoy the quality and purity of the fruit. Did you know? Mendoza has more hectares (156,570) under vine than Bordeaux. The first Aberdeen Angus bull was imported to Argentina in 1879 and was named Virtuoso; he was accompanied by two heifers called Cinderella and Aunty Lee. *MALBeC-DOMINANT BLEND* POESIA 2005 Mendoza 17 Drink 2008-11 60% Malbec, 40% Cabernet Sauvignon from Luján de Cuyo; aged in 100% new French oak barrels. Fragrant, gently cedary, peppery and then smoky on the palate. Dry and fresh and persistent. Dry and attractive restraint. 14.5% (JH)"

The winery's flagship is called POESIA and is a blend of 60% Malbec and 40% Cabernet Sauvignon. It too is sourced from an 80 year old vineyard in Lujan de Cuyo. The 2005 POESIA was barrel-fermented and aged for 18 months in 100% new French oak. Opaque purple-colored, it has a high-class aromatic array of pain grille, violets, spice box, black cherry, and blueberry. Smooth-textured, ripe, and sweetly-fruited, this elegant wine is beautifully balanced, nicely concealing enough structure to permit 5-7 years of evolution. It should drink well through 2030. A barrel sample of the 2006 was also impressive. Ms. Garcin also presented the 2002 (88), 2003 (90+), and 2004 (91), all fine efforts but the 2005 and 2006 are the best yet.
